

## PREFIX REGISTRATION APPLICATION

## **Instructions:**

- 1. Print in ink only (please write legibly).
- 2. A \$15 fee MUST accompany this form if submitting via mail.
- 3. Review the prefix rules listed below before filing this application.
- 4. Retain a copy of the completed form for your future reference.

## **Prefix Registration Fee: \$15**

A <u>registered</u> prefix is a combination of letters, words, or names proceeding or following a pony's registered name and is used exclusively by the owner of the prefix in regards to ponies registered with the International Chincoteague Pony Association & Registry LLC.

A name, word, letter, or combination of these, preceding a name, <u>not recorded</u> as a prefix with ICPAR, may be used by other breeders, until registered with ICPAR for the exclusive use of one breeder.

A prefix registered with ICPAR can only be used by the recorded owner of that prefix. The registered owner of a prefix may grant permission, in writing and on file with the Registry, to designated person(s) to allow use of that prefix.

Prefix Example: MCC's Scottish Princess

(The "MCC's" is a prefix that stands for "Midwest Chincoteague Connections" and in this case it precedes the pony's name)

## Prefixes must meet the following criteria:

- 1. The word is not the complete name of a Chincoteague pony that has lived in the past one hundred years.
- 2. The word cannot be the complete name of a Chincoteague pony that has registered offspring.
- 3. The prefix applicant shall not have another registered prefix on record with ICPAR.
- 4. The Registry does not deem the prefix to be confusingly similar to a name or prefix previously recorded or otherwise unsuitable.
- 5. The prefix application has been correctly completed and submitted with the appropriate fee.

NOTE: You're **NOT** required to register all of your foals with your farm prefix.
